1: General Education Core Requirements, see Graduation Requirements section of this catalog. Follow requirements with these stipulations: Lab Science-Select BIOL 1153/1151 and select another without the prefix BIOL; Fine Arts-HUMN 2563 is required; History/Government-POLS 2753 is required and select either HIST 2753 or 2763.

2: These courses are used to determine major courses in residency, see Graduation Requirements section of this catalog.

3: Student must have a minimum of 2.75 in these courses to meet graduation requirements, School of Education.

4: Requirements for Admission in Teacher Education Program (TEP). Must be completed with required grades for admission requirements. Consult with faculty advisor regarding School of Education admission requirements and for courses taken after admission to program.

5: Offered on a rotating schedule and may be taken out of sequence.

6: Must be admitted to the School of Education, Teacher Education Program.

7: The department requires students to meet a piano proficiency. Students with little or no piano abilities will be required to pass (with a minimum grade of "C") up to four hours of class piano (MUSC 1161, 1171, 2161, and 2171).

8: Program requirement-course must be completed with a grade of "B" or better.

Prior to graduation students must demonstrate competency in financial literacy by satisfactory completion of FIN 1521 Personal Finance Applications (or an approved substitution) with a grade of C or better, or by score a 70% or more on a challenge exam for FIN 1521.

Transfer Course Information

By signing below it is understood that admission is by application to the Teacher Credential and Standards Committee (TCSC) of the Teacher Education Council (TEC). Applications are available from the School of Education. Once admitted, students must maintain satisfactory progress throughout the completion of the teacher education program according to the criteria cited above and any additional program standards in effect or lose eligibility to continue the program.

Student Degree Program Requirements.

A student's degree program requirements are those specified in the catalog in effect at the time of declaration of program major. Students must meet the above program requirements and the graduation requirements as indicated by institutional and college policy. The program can be changed only with the approval of the official advisor.

If original courses are eliminated, students may be required to meet new curriculum requirements in the degree program. If students are not enrolled for two or more consecutive terms (excluding summer terms), they must re-enter under the program requirements of the current catalog. Students are responsible for understanding program requirements and changes.
