1: General Education Core Requirements, see Graduation Requirements section of this catalog. Follow requirements with these stipulations: lab science-select BIOL 1153/1151 and select another without the BIOL prefix; fine arts-must choose HUMN 2563; history/government-POLS 2753 is required and select either HIST 2753 or 2763.

2: These courses are used to determine major courses in residency, see Graduation Requirements section of this catalog.

3: Requirements for Admission in Teacher Education Program (TEP).Must be completed with required grades for admission requirements. Consult with faculty advisor regarding School of Education admission requirements and for courses taken after admission to program.

4: Must be admitted to the School of Education, Teacher Education Program.

5: The department requires students to meet a piano proficiency. Students with little or no piano abilities will be required to pass (with a minimum grade of C) up to four hours of class piano (MUSC 1161, 1171, 2161, and 2171).

Prior to graduation students must demonstrate competency in financial literacy by satisfactory completion of FIN 1521 Personal Finance Applications (or an approved substitution) with a grade of C or better, or by a score of 70% or more on a challenge exam for FIN 1521.

A student earning a bachelor of music education – vocal music degree will have completed the requirements to be eligible to apply for teacher licensure in vocal music K-12 as issued by the Arkansas State Department of Education.

Students must earn a C or higher in all courses on the degree plan. Students must maintain a 2.75 cumulative GPA or better. GPA is tracked throughout the program and verified for admission into internship.

Transfer Course Information

The Arkansas Course Transfer System (ACTS) contains information about the transferability of courses within Arkansas public colleges and universities. Students are guaranteed the transfer of applicable credits and the equitable treatment of the application of credits for the admissions and degree requirements. By signing below it is understood that admission is by application to the Teacher Credential and Standards Committee (TCSC) of the Teacher Education Council (TEC). Applications are available from the School of Education. Once admitted, students must maintain satisfactory progress throughout the completion of the teacher education program according to the criteria cited above and any additional program standards in effect or lose eligibility to continue the program.

Student Degree Program Requirements.

A student’s degree program requirements are those specified in the catalog in effect at the time of declaration of program major. Students must meet the above program requirements and the graduation requirements as indicated by institutional and college policy. The program can be changed only with the approval of the official advisor. If original courses are eliminated, students may be required to meet new curriculum requirements in the degree program. If students are not enrolled for two or more consecutive terms (excluding summer terms), they must re-enter under the program requirements of the current catalog. Students are responsible for understanding program requirements and changes. This document is not official until signed and dated by both the student and an authorized university representative.
